As of 12 June 2026, the EU Pact on Migration and Asylum will enter into application in EU Member States. Some of the EU Pact instruments may worsen the human rights situation of children, including more systematic detention of migrant children and related human rights violations.

Detention of children for the purposes of immigration has severe consequences for children, affecting their psycho-social development and well-being, interrupting their education, and exposing them to heightened risks of trafficking, exploitation, and abuse. Children should never be detained, and States must instead develop and implement rights-based alternatives to detention for children while their status is pending or are awaiting deportation.

The event will explore the implications of the EU Pact on Migration and Asylum for both unaccompanied and accompanied children, and present a guide exploring how strategic litigation can be used to protect migrant children from detention in EU Member States. This event aims to strengthen advocacy, litigation, and collaboration among practitioners, policymakers, and civil society representatives committed to protecting the rights of migrant children. Discussion will focus on the role of EU institutions, Member States, and legal professionals in ending the immigration detention of children.

*Building on [existing work](#), the [RELEASE Project](#) (Protecting Migrant Children against Detention through the EU Charter) promotes the expansion and implementation of viable, rights-based alternatives to detention for *migrant children at risk of being subjected to unlawful detention or whose rights may be violated in alternatives to detention*. Over two years, the Partners—ICJ, Aditus Foundation, DCI-Belgium, Forum for Human Rights, Helsinki Foundation for Human Rights, Greek Council for Refugees, Foundation for Access to Rights—contributed to fostering a favorable EU environment to protect migrant children from detention in Belgium, Bulgaria, the Czech Republic, Greece, Malta, and, Poland. The project facilitated exchanges focusing on litigation venues and strategies, including before the [CJEU](#), the [UN Treaty Bodies](#), the European Committee of Social Rights ([ECSR](#)), and the European Court of Human Rights ([ECtHR](#)). This final event presents some of the project's findings, allowing exchanges and exploring future needs and ways forward to the end detention of migrant children.*
