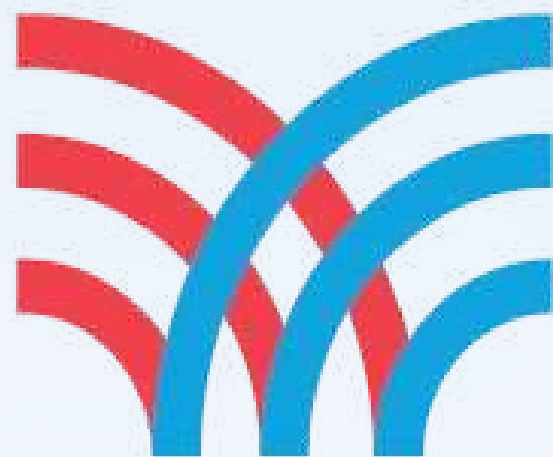

Transforming Boilerplate into Strategic Advantage

Arbitration clauses are often seen as boilerplate, yet they can significantly affect the efficiency, cost, and outcome of disputes long after a contract is signed.

Representatives from the London Court of International Arbitration (LCIA) will lead a session on common pitfalls in disputes that arise from international commercial relationships and complex multi-party or multi-contract arrangements, including those common in the funds industry. Participants will get practical guidance on topics such as arbitrability, selecting the place of arbitration, choosing institutional rules, and drafting clauses to avoid costly jurisdictional disputes. The session will focus on issues relevant to the Luxembourg market.

Whether you regularly negotiate commercial agreements or oversee cross-border transactions, this session will provide valuable tools to ensure your dispute resolution clauses are fit for purpose from the outset.

From Reform to Recognition: Building the Future of Luxembourg as an International Arbitration Hub

Over the past few years, Luxembourg has undergone a remarkable transformation in the field of arbitration. The adoption of the new Arbitration Law in 2023, the continued modernization of the Luxembourg Arbitration Center (LAC), the revision of its institutional framework, have collectively strengthened Luxembourg's position as a modern and internationally oriented arbitral seat.

At a time when businesses are demanding more efficient, flexible and technology-driven dispute resolution mechanisms, Luxembourg is increasingly positioning itself as a credible alternative to established European arbitration hubs.

This panel brings together different perspectives—arbitrator, judge, academic, Secretary General of the Luxembourg Arbitration Center—to examine the latest developments in Luxembourg arbitration and explore the opportunities and challenges that lie ahead.

The discussion will not only assess the impact of recent reforms but will also address broader questions concerning efficiency, technology, artificial intelligence, financial disputes, and the future attractiveness of Luxembourg as a seat of arbitration.
